ARTICLES I - NAME

This name of this organization is Esteem Designs, Inc.

ARTICLE II - PURPOSE

This company is organized for the purpose of engaging in the business of installing new cabinets, installing finish woodwork, and general construction services, for the accomplishment of said purposes, and to do all and other things incidental to them, or connected with them, that are not forbidden by Florida corporation laws or by other laws, or by these Articles of Incorporation, and to carry out said purpose in any state, territory, district, or possession of the United States or in any foreign country, to the extent that these purposes are not forbidden by the laws of that state, territory, district, or possession of the United States, or by the foreign country.

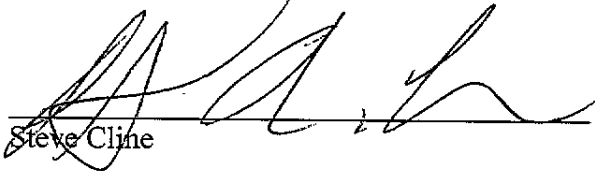
ARTICLE VIII - INDEMNIFICATION

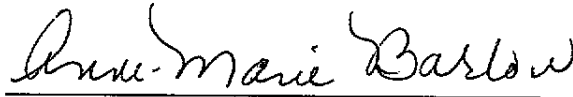

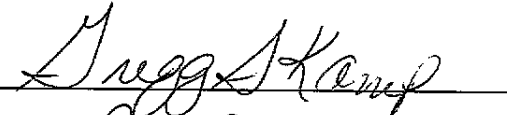
