ARTICLES OF INCORPORATION

OF

SKY WORLD AIR TOURS, INC.

The undersigned hereby makes, subscribes, and files these Articles for the purpose of forming a corporation under the laws of the State of Florida:

ARTICLE I

<u>Name</u>

The name of this corporation shall be SKY WORLD AIR TOURS, INC.

ARTICLE II

Purpose
