ARTICLE I-Name

The name of this corporation is Sherianne's Enterprises, Inc.

ARTICLE II- Principal Office

ARTICLE III-Duration

This corporation shall have perpetual existence.

ARTICLE XI-Amendment

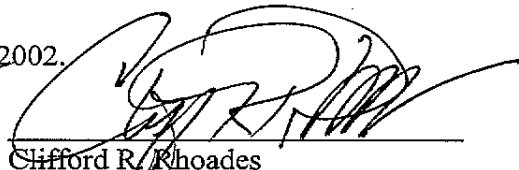

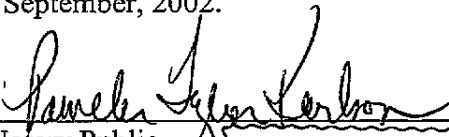

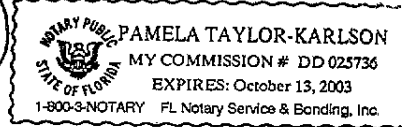
