# ARTICLES OF INCORPORATION

## ARTICLE I NAME

The name of the Corporation is: D.R. GUARINO, INC., a domestic corporation which is not a member of any affiliated group.

## ARTICLE II PRINCIPAL OFFICE

The principal place of business of this corporation shall be: 825 Bayview Drive, Ruskin, Florida 33570.

## ARTICLE III PURPOSE

The general purposes for which the Corporation is organized are:
