ARTICLES OF INCORPORATION OF 6039 REAL ESTATE INVESTMENTS, INC.

The undersigned a natural person, competent to contract, hereby subscribes to these articles of Incorporation for the purpose of forming a corporation pursuant to the Florida Beneral Corporation Act, Florida Statutes, Chapter 607.
