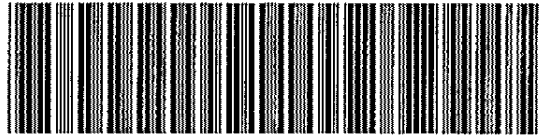

ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION

OF

Pursuant to the provisions of Section 607.1003 and 607.1006, Florida Statutes, the undersigned corporation adopt the following amendment to its Articles of Incorporation.

1. The name of the Corporation as stated in the Articles filed on October 1, 2002 is Dvorak-Sensenig, Inc.

3. Article I, of the Articles of Incorporation of, is hereby amended and restated in full to read as follows:

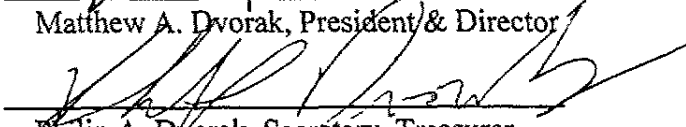

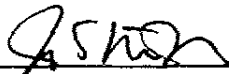
