ARTICLES OF INCORPORATION
OF
IFI HOLDINGS, INC.

The undersigned, acting as the incorporator of IFI HOLDINGS, INC., under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation is:
