The undersigned subscribed to these Articles of Incorporation, a natural person competent to contract, hereby seeks to form a corporation for profit under the laws of the state of Florida.

ARTICLE 1. Name

The name of this corporation is: SOLAR ENERGY TECHNOLOGY INDUSTRIES, INC.

ARTICLE 2. Principle office

The principle office is located at 112 Thornton Drive, Palm Beach Garden, Florida 33418

ARTICLE 3. Purpose

To carry on the business of distilling ocean, river, sea, and lake water and sell the same. To mine the ocean for all minerals and sell the same. To carry on the business of buying, selling, and developing land. To carry on the business of buying and selling houses, townhomes, condominiums, and all commercial property. 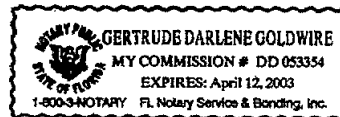
