ARTICLES OF INCORPORATION
OF
KIDS EDUCATION ENRICHMENTS PROGRAM, INC.

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation ("Corporation") is Kids Education Enrichments Program, Inc.

ARTICLE II

The existence of the Corporation shall begin on October 4, 2002.

ARTICLE III

The street address of the principal office of the Corporation is 1155 Hillsboro Mile #10, Hillsboro Beach, FL 33062 and the mailing address is P.O. Box 030445, Fort Lauderdale, FL 33303.

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is 1,000, par value \$.01 per share, all of which shall be Common Shares. All Common Shares shall be identical with each other in every respect and the holders of Common Shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.

ARTICLE V

The initial street address of the Corporation's registered office is 1155 Hillsboro Mile #10, Hillsboro Beach, FL 33062. The initial registered agent for the Corporation at that address is Larry Shore.

ARTICLE VI

The name and street address of the person signing these articles of incorporation is Larry Shore, 1155 Hillsboro Mile #10, Hillsboro Beach, FL 33062.

ARTICLE VII

The Corporation shall indemnify its directors, officers, employees, and agents to the fullest extent permitted by law.

ARTICLE VIII

The purpose for which the Corporation is organized is to provide education resources for children.

ARTICLE IX


The method of election of directors of the Corporation shall be as stated in the bylaws.
