The name of the corporation shall be Print Java, Inc.

**ARTICLE II - DURATION**

The corporation shall have a PERPETUAL existence unless dissolved according to law. Corporate existence shall commence upon filing of Articles of Incorporation with the Secretary of State for the State of Florida.

**ARTICLE III - PURPOSE OF CORPORATION**

The corporation is organized for the purpose of transacting any and all lawful business for which corporations may be incorporated in the State of Florida. The general nature and objectives of this corporation shall be as follows:

- 1) To establish an Internet based company to design, print and offer for sale to the general public high quality office and business supplies including, but not limited to, business cards, stationary and signage.

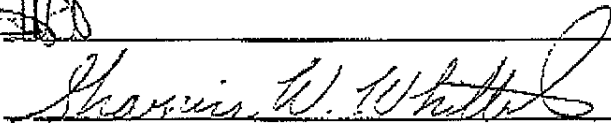
**ARTICLE VIII - AMENDMENTS TO ARTICLES OF INCORPORATION**

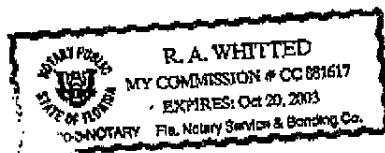

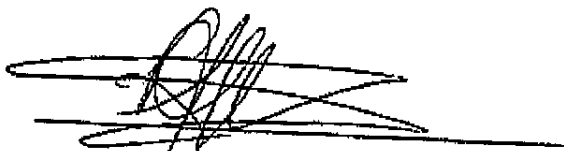

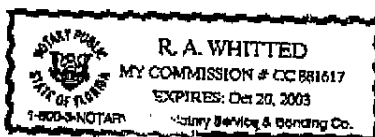
