ARTICLE XII - BY- LAW

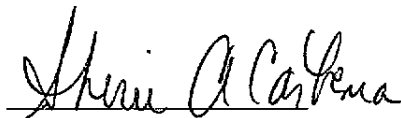
The by-laws of this corporation may be adopted, altered, amended or replaced by the shareholders.

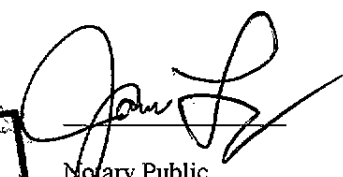
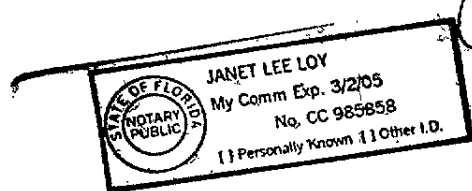
