# ARTICLES OF INCORPORATION

## OF

### AROMA MOMENTS, INC.

THE UNDERSIGNED, for the purpose of forming a corporation under Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

#### ARTICLE I

##### NAME OF CORPORATION

The name of the Corporation is **AROMA MOMENTS, INC.**

#### ARTICLE II

##### DURATION

The duration of the Corporation is perpetual. Corporate existence shall commence upon the proper filing of these Articles in the Office of the Secretary of State of the State of Florida.

#### ARTICLE III

##### PURPOSE

The purpose of this corporation is to manufacture, import, produce, package, distribute and market wholesale and retail specialty items, and any other activity allowed or authorized by Chapter 607, Florida Statutes.

#### ARTICLE IV

ARTICLE VIII


BYLAWS

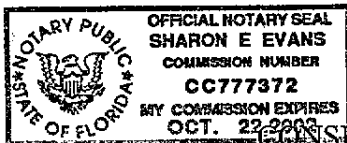




