We the undersigned individuals, hereby associate ourselves for the purpose of becoming a Corporation under the laws of the State of Florida under the provisions of these Articles of Incorporation, it-wit:

Article I

The name of this corporation shall be MYRTLE'S KITCHEN, CORP.

Article II

The general nature of the business to be conducted by this Corporation shall be as follows, to-wit:

To engage in the preparation and sale of food in the restaurant industry. To purchase, hold, sell, improve and lease real estate, and mortgage and encumber the same, and to erect, manage, care for and maintain, extend and alter buildings thereon, within or without Florida. To acquire the good will, rights and property and to undertake the whole or any part of the asset and liabilities of any person, firm, association or corporation, to pay for the same in case, the stock of this company, bonds or otherwise, to hold or in any manner to dispose of, the whole or any part of the property so purchased, to conduct in any lawful manner the whole or any part of any business so acquired and to exercise all the powers necessary or convenient in and about the conduct and management of such business, within or without Florida.
