ARTICLE I. NAME

The name of this corporation shall be Michael P. Aubut, P.A.

This corporation shall have perpetual existence commencing on January 1, 2003.

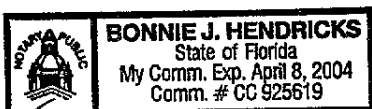
