
ARTICLE XI

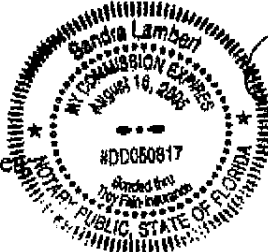
