ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF CORPORATE AIRFARES CORP

Pursuant to the provisions of F.S. 607.1006, this Florida Corporation adopts the following articles of amendment to its Articles of Incorporation as follows: $\frac{1}{2}$

FIRST AMENDMENT ARTICLE 1 - Name and Address Update

CORPORATE AIRFARES, CORP. 1835 East Hallandale Beach Bivd., Ste. 223 Hallandale Beach, Florida 33009

SECOND AMENDMENT ARTICLE 2- Duration/Effective Date

This Corporation shall have perpetual existence commencing the date of filing of the original Articles of Incorporation.

THIRD AMENDMENT ARTICLE 3 - Purpose

The general purposes for which the Corporation is organized are the following:

- A. Provide services to the business community related to obtaining airline tickets and travel accommodations.
- B. To do such other things as are incidental to the purposes of the Corporation or necessary or desirable in order to accomplish them.
- C. To engage in and transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act.

FOURTH AMENDMENT ARTICLE 4 - Capital Stock Increase

NINTH AMENDMENT ARTICLE 9 - Indemnification

The Corporation shall indemnify each Officer and Director, including former Officers and Directors, to the full extent permitted by law.

TENTH AMENDMENT ARTICLE 10 - Preemptive Rights

Each Shareholder of the Corporation shall have the right to purchase, subscribe for, or receive a right or rights to purchase or subscribe for, at the price for which it is offered to others, that Shareholder's pro rata portion of the following:

A. Any stock of any class that the Corporation may issue or sell, whether or not exchangeable for any stock of the Corporation of any class or classes, and whether or not of unissued shares authorized by the Articles of Incorporation as originally filed or by any

amendment thereof or out of shares of stock of the Corporation acquired by it after the issuance thereof, and whether issued for cash or other consideration; or

B. Any obligation that the Corporation may issue or sell which is convertible into or exchangeable for any stock of the Corporation of any class or classes, or to which is attached or pertinent any warrant or warrants or other instruments conferring on the holder the right to subscribe for or purchase from the Corporation shares of its stock of any class or classes.

This right shall be deemed waived by any Shareholder who does not exercise it and pay for the shares preempted within thirty (30) days after receipt of written notice from the Corporation stating the price, terms and conditions of the issue of shares and inviting the Shareholder to exercise this preemptive right. This right may also be waived by a written waiver signed by the Shareholder.

ELEVENTH AMENDMENT ARTICLE 11 - Calling of Special Meetings

Special meetings of shareholders may be called by written notice, delivered to each shareholder, ten (10) business days prior to the meeting date.

TWELFTH AMENDMENT ARTICLE 12 - Shareholder Quorum and Voting

FIFTY-ONE PERCENT (51%) of the shares entitled to vote, represented in person or by proxy, shall constitute a quorum at a meeting of the shareholders. If a quorum is present, the affirmative vote of FIFTY-ONE PERCENT (51%) of the shares represented at the meeting and entitled to vote on the subject matter shall be the act of the shareholders.

THIRTEENTH AMENDMENT ARTICLE 13 - Management of Corporation by Directors

All Corporate powers shall be exercised by or under the authority of, and the business affairs of this Corporation shall be managed under the direction of the Board of Directors of this Corporation.

FOURTEENTH AMENDMENT ARTICLE 14 - Meetings by Conference Telephone

Members of the Board of Directors may participate in meetings of the Board of Directors by means of conference telephone as provided by law.

FIFTEENTH AMENDMENT ARTICLE 15 - Action by Directors Without a Meeting
The Directors of this Corporation may take action by written consent, as provided by law.

SIXTEENTH AMENDMENT ARTICLE 16 - Director Quorum and Voting

SEVENTEENTH AMENDMENT ARTICLE 17 - Removal of Directors

EIGHTEENTH AMENDMENT ARTICLE 18 - Bylaws

The power to adopt, alter, amend or repeal the Bylaws shall be vested in the Board of Directors, but all alterations, amendments and repeals of the Bylaws must be approved by a majority of the Shareholders.
