**ARTICLES OF INCORPORATION**  
**OF**  
**R-Tistic Furniture and Design, Inc.**

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

**ARTICLE I**

The name of the corporation is R-Tistic Furniture and Design, Inc. whose principal place of business is 1558 S.E. Neimeyer Circle Port St. Lucie, Florida 34952

**ARTICLE II**

The period of duration of the corporation is perpetual.

**ARTICLE III**

The purpose or purposes for which the corporation is organized are to engage in any activity or business permitted under the laws of the United States and of this State.

**ARTICLE IV**

The corporation shall have the authority to issue one thousand (1,000) shares, all of one class of Common Stock, with no Par Value per share.

**ARTICLE V**

The address of its initial registered office is 1558 S.E. Neimeyer Cr. Port St. Lucie, Fla. 34952 and the name of its initial registered agent at said address is Art Lobe.

## **ARTICLE VI**

**The number of directors constituting its initial Board of Directors is one (1), whose name and address is; Art Lobe, 1558 S.E. Neimeyer Cir. Port St. Lucie, Fl. 34952**

## **ARTICLE VII**

**The name and address of the incorporator is: Art Lobe, 1558 S.E. Neimeyer Cir. Port St. Lucie, Fla. 34952.**

## **ARTICLE VIII**

**The share holder(s) shall have the power to adopt, amend, alter, change, or repeal the Articles of Incorporation when proposed and approved at a stockholder's meeting, with not less than a two-thirds vote of the common stock.**

## **ARTICLE IX**

**The power to adopt, alter, amend or repeal By-Laws shall be vested in the Board of Directors.**


## **ARTICLE X**

**The holders of the common stock of this corporation shall have preemptive right to purchase, at prices, terms, and conditions that shall be fixed by the Board of Directors, such of the shares of the stock of this corporation as may be issued for money (money or any property or services) from time to time, in addition to that stock authorized by the corporation. The preemptive right of any holder is determined by the ration of the authorized shares of common stock held by the holder to any shares of common stock currently authorized.**

## ARTICLE XI

Pursuant to Florida Statue Section 607.0203, the effective date of the commencement of the corporation existence is the 25<sup>th</sup> day of September, 2002, which is the date of subscription and acknowledge of the Articles of Incorporation. Said Articles of Incorporation are to be filed with five days after such date.




