#### **ARTICLE IX - Purpose or Purposes**

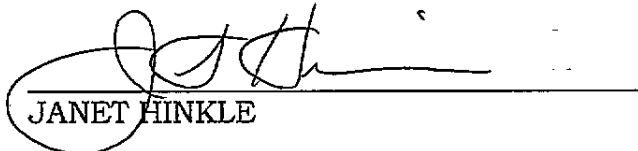

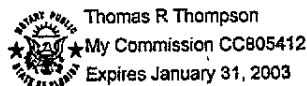
