The undersigned, for the purpose of forming a corporation under the Florida Statutes Chapter 607, hereby make, acknowledge, and file the following Articles of Incorporation.

**ARTICLE I – NAME**

The name of the corporation shall be MATE Arts & Crafts, Inc.

**ARTICLE II – PRINCIPAL OFFICE**

The principal place of business and mailing address is 336 SE 15<sup>th</sup> Avenue, Deerfield Beach, Florida 33441.

**ARTICLE III – PURPOSE**


