# ARTICLES OF INCORPORATION OF

I, the undersigned, being of sound mind and of legal age, do hereby agree for myself to become a comporation UNIDA for profit under the laws of the State of Florida, providing for the formation, liability, rights, privileges, benefits and obligations conferred and imposed by such laws on corporations organized pursuant to the provisions thereof, and do hereby make, subscribe, acknowledge and agree to file these articles of incorporation as follows:

#### ARTICLE I - NAME

The name of this corporation shall be NETWORK SERVICE TELEVISION, INC.

#### ARTICLE II - DURATION

This corporation shall have perpetual existence. The corporation's existence shall commence on the date of acknowledgement by the Secretary of State.

#### ARTICLE III - PURPOSE

The general nature of the business to be transacted by this corporation is to include any and all lawful business or activities permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.

#### ARTICLE IV - STOCK
