The undersigned, acting as incorporator of the captioned corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I

CORPORATE NAME AND PRINCIPAL OFFICE

The name of this corporation is THOROUGHbred GUITARS, INC. and its principal office and mailing address is 3108 Central Drive, Plant City, FL 33567.

COMMENCEMENT OF CORPORATE EXISTENCE
