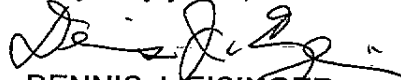

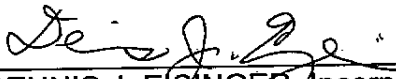
ARTICLE X

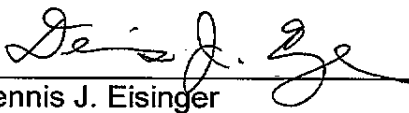
