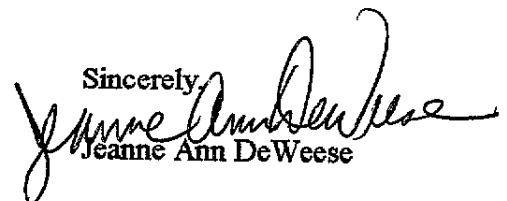

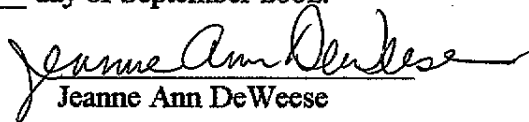

BY-LAWS AND PURPOSE**

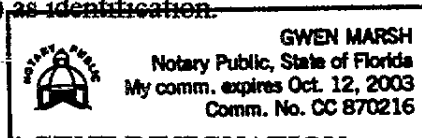

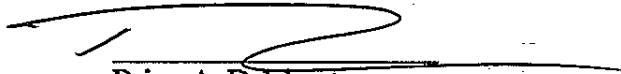
