**ARTICLES OF INCORPORATION
Of
J&B'S GAS PLUMBING, INC.**

ARTICLE I – NAME

The name of this corporation is J&B's Gas Plumbing, Inc.

ARTICLE II – DURATION

This corporation shall have perpetual existence.

ARTICLE III – PURPOSE

This corporation is organized for the following purposes:

1. To engage in Gas Plumbing installation and maintenance.
2. To transact any other lawful business.

ARTICLE X – AMENDMENT

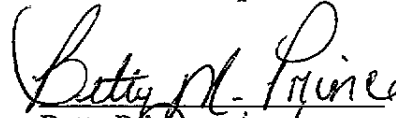
