## ARTICLES OF INCORPORATION of FAR & SONS, INC.

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, adopt the following Articles of Incorporation:

#### **ARTICLE I**

#### NAME

The name of the corporation is: FAR & SONS, INC.

#### ARTICLE II

#### PRINCIPAL OFFICE

The duration of the corporation is perpetual.

#### ARTICLE IV

#### **PURPOSE OR PURPOSES**
