ARTICLES OF INCORPORATION

OF

STEVEN P. PERA, PSY. D., P. A.

The undersigned incorporator, for the purpose of forming a corporation under Chapter 607 of the laws of the State of Florida, hereby adopts the following Articles of Incorporation.

ARTICLE 1 - NAME

The name of the Corporation shall be Steven P. Pera, PSY. D., P. A. (hereinafter, "Corporation").

ARTICLE 2 - NATURE OF BUSINESS

The general nature of the business to be transacted by this corporation shall be to engage in every aspect of the practice of psychology. The professional services rendered by the corporation (as stated in Florida Statutes Chapter 621) may be rendered only through individuals duly licensed to render professional services as a psychologist under the laws of the State of Florida. The corporation shall not engage in any business other than the practice of psychology. However, the corporation may invest funds in real estate, mortgages, stocks, bonds or any other type of investment and may own real and personal property necessary for the rendering of professional psychological services.

The Common Stock of the corporation may not be issued to anyone other than an individual who is duly licensed to render professional psychological services. No shareholder of the corporation shall enter into a voting trust agreement or other type of agreement vesting any other person with the authority to exercise the voting power of any or all of the shareholder's share of Common Stock of the corporation.



These Articles of Incorporation are to be effective upon approval by the Secretary of State of the State of Florida


