I am respectfully writing to request a waiver of the \$600 reinstatement fee for the registration of my company, A House of Long Life, Inc. under the aforementioned document number.

When I registered my company with the State of Florida in 2002, I had thought I would begin to conduct business immediately, but I did not. Being a new business owner, I did not realize that I had to renew my corporation annually with the state whether I conducted business or not. It wasn't until just recently that I was made aware of this fact.

I do not recall ever having seen any renewal forms from the state, but I acknowledge that it is possible that they were mailed. It's just that being a new business owner I would not have known to expect a renewal form or even what to look for in the mail, given how little I knew of the registration process.
