

The undersigned, for the purposes of forming a corporation under Section 607.0202 of the Florida Business Corporation Act, does hereby certify as follows:

ARTICLE I  
Corporate Name and Address

The name of the Corporation is Fabricare Delivery Services, Inc., and the street address of the Corporation is 73 Commercial Boulevard, Naples, Florida 34104.

ARTICLE II  
Corporate Purposes

The Corporation is organized to transact any and all lawful business authorized by the Florida Business Corporation Act.

ARTICLE III  
Authorized Stock

The aggregate number of shares of the Corporation shall be 10,000, all of which are to be voting common stock having a par value of one cent (\$0.01) per share.

ARTICLE IV  
Registered Office and Registered Agent


ARTICLE VII


