The undersigned incorporator, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I NAME

ARTICLE II NATURE OF BUSINESS

This corporation will engage in a professional manner, any or all lawful health care and social assistance services and activities permitted under the laws of the United States, the state of Florida, or any other state, country, territory or nation.

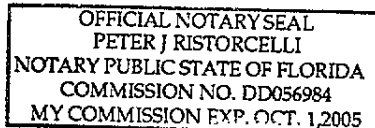

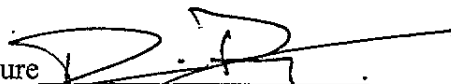
