To Whom It May Concern:

Enclosed please find a check in the amount of \$150.00 from Envision Financial Solutions, Inc. The document # is P02000109631. A copy of the Uniform Business Report obtained from your website is also enclosed.

I am a 22 year old man, who is trying to start a company. I was fortunately able to borrow \$1000.00 from a close personal friend of mine in order to begin my business.

I used a Paralegal firm to file the documents needed for a corporation in the State of Florida. Not having the knowledge of your website www.sunbiz.org, instead of paying approximately \$90 to incorporate through your website, I paid \$210.00 to the paralegal firm for my corporation. I also opened a corporate bank account thru Bank of America; and applied for and received a Federal Tax ID# with the Internal Revenue Service.

Now to the purpose of this letter. I realize there is a great responsibility in starting your own company, and I have tried to meet all that is required of me in order to comply with City, County, State and Federal rules and regulations. Due to the fact that I have limited experience (learning more everyday) and moving from place to place, I never received the Uniform Business Report, nor was ever told by the paralegal firm that there was such a form to fill out along with a filing fee by a specific date. I still have never received the Uniform Business Report Form, but have found out recently through a friend that there is such a form required to be filled out along with a fee of \$150.00 in order to maintain my corporate status.

I am not using my youth, nor lack of experience to make excuses, but in speaking with the Department of Corporations for the State of Florida, I learned there is a penalty of \$400.00 for filing past the mandatory deadline. I was also told by the Department of Corporations that if the State of Florida does not receive my paperwork, along with a check no later than Sept, 8th 2003, my corporation can be dissolved.

I am asking for a waiver of the \$400.00 penalty, one time and one time only, so that I may keep my corporation alive and preserve as much cash as possible in order to operate on a day to day basis.

I am hoping you will take all of this into consideration when deciding whether to waive the \$400.00 penalty for not filing on time as required by Florida law.

Thank you for your kind attention to this matter, and hoping to receive a favorable response.
