

CORPORATE NAME**



This Corporation shall commence its existence on the date upon the Articles of Incorporation are executed and acknowledged.



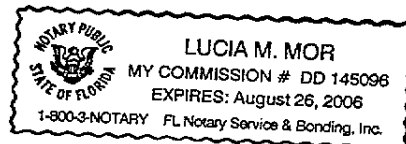


