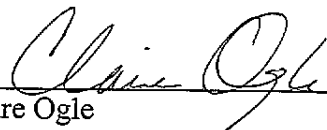

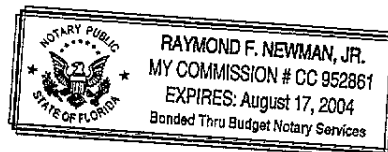

**ARTICLES OF INCORPORATION  
OF  
VOICE OF THE BRIDE, INC.**

The undersigned subscriber to these Articles of Incorporation, being a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

**ARTICLE I. NAME**

The name of the corporation is VOICE OF THE BRIDE, INC. The principal office for doing business in the State of Florida is 155 Paradise Point Lane, Santa Rosa Beach, FL 32459.

**ARTICLE II. PURPOSE**

This corporation is organized for the purpose of any or all lawful business for which corporations may be incorporated under Chapter 607 of the Florida Statutes, or any other applicable Florida Law.

**ARTICLE III. CAPITAL STOCK**

This corporation is authorized to issue One Hundred (100) shares of common stock having a par value of \$1.00 per share. This stock shall have the entire voting power of the corporation.
