ARTICLES OF INCORPORATION OF:

M.A.M. CLEANING COMPANY, INC.

The undersigned subscriber to these Articles of Incorporation is a Natural Person competent to contract and hereby form a Corporation for profit under Chapter 607 of the Florida Statutes.

ARTICLE I - NAME

- 3. No shareholder of the Corporation may sell or transfer his stock in this corporation. except to another individual who is eligible to be a shareholder of the corporation.
