ARTICLES OF INCORPORATION OF U.S.A. FLOOR COVERING, INC.

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a namual person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLEI

The name of the Corporation ("Corporation") is U.S.A. FLOOR COVERING, INC.

ARTICLE II

The existence of the Corporation shall begin on October 14, 2002.

ARTICLE III
