The undersigned subscriber to these Articles of Incorporation is a natural person competent to contract and hereby form a professional service Corporation for profit under Chapter 621 of the Florida Statutes.

# **ARTICLE 1 - NAME**

The name of the Corporation is **ISLAND VETERINARY CARE CENTER**, **PA**, (hereinafter, "Corporation").

# **ARTICLE 2 - PURPOSE OF BUSINESS**

The Corporation shall engage in the practice of veterinary medicine.

# **ARTICLE 3 - PRINCIPAL OFFICE**

The address of the principal office of this Corporation is 919 Panferio Drive, Pensacola Beach, Florida 32561, and the mailing address is the same.

# **ARTICLE 4 - INCORPORATOR**

The name and street address of the incorporator of this Corporation is Scott Sandfort, Bass and Sandfort Accountants, PA whose address shall be 1301 West Garden Street, Pensacola, Florida 32501.

# ARTICLE 5 - OFFICERS

#### **ARTICLE 6 - DIRECTOR(S)**

#### ARTICLE 7 - CORPORATE CAPITALIZATION

- 7.1 The maximum number of shares that this Corporation is authorized to have outstanding at any time is **SEVEN THOUSAND FIVE HUNDRED (7,500)** shares of common stock, each share having the par value of **ONE DOLLAR (\$1.00)**.
- 7.2 All holders of shares of common stock shall be identical with each other in every respect and the holders of common shares shall be entitled to have unlimited voting rights on all shares and be entitled to one vote for each share on all matters on which Shareholders have the right to vote.
- 7.3 All holders of shares of common stock, upon the dissolution of the Corporation, shall be entitled to receive the net assets of the Corporation.

The Corporation, to the extent permitted by law, shall be entitled to treat the person in whose name any share or right is registered on the books of the Corporation as the owner thereto, for all purposes, and except as may be agreed in writing by the Corporation, the Corporation shall not be bound to recognize any equitable or other claim to, or interest in, such share or right on the part of any other person, whether or not the Corporation shall have notice thereof.

# ARTICLE 12 - REGISTERED OFFICE AND REGISTERED AGENT
