

ARTICLES OF INCORPORATION

OF

SHAWARMA PLUS, INC.

ARTICLE I

NAME: The name of this corporation is: **SHAWARMA PLUS, INC.**

ARTICLE II

COMMENCEMENT OF EXISTENCE: This corporation shall commence to exist on the date filed with the Secretary of State.

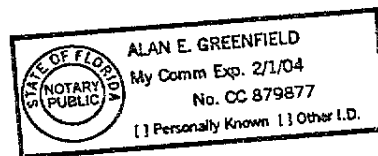


