ARTICLES OF INCORPORATION OF KENNETH RICHARD CATE, P.A.

SECRETARY OF STATE TALLAHASSEE, FLORIDA

The undersigned, being duly licensed to practice law in the State of Florida, desires to form a professional corporation in accordance with Chapter 607 of the Florida Statutes and the Florida Professional Service Corporation Act, adopts the following Articles of Incorporation.

ARTICLE 1

<u>Name</u>

The name of this corporation is:

ARTICLE 2

Duration

This corporation shall have perpetual existence, commencing upon filing.

ARTICLE 3

Principal Office and Mailing Address

The address of the principal office and the mailing address of this corporation is:

ARTICLE 4

Purpose

The purpose for which this corporation is organized shall be to engage in the practice of law within the State of Florida, and to take all actions that are necessary or proper in connection with that practice.

This corporation elects to have preemptive rights.
