ARTICLE I: CORPORATE NAME

The name of this Corporation is **We Care Mobile Detailing, Inc.**, and its mailing address is, **5901 58th Ave. North, Saint Petersburg, FL 33709**.

ARTICLE II: NATURE OF BUSINESS

This Corporation may engage in or transact any or all lawful activities or business permitted under the laws of the United States, the State of Florida, or any other state, country, territory or nation.

ARTICLE III: CAPITAL STOCK

The maximum number of shares of stock that this Corporation is authorized to issue and have outstanding at any one time is **200** shares of common stock having par value of one **(\$1.00)** dollars.

ARTICLE IV: TERM OF EXISTENCE

This Corporation shall have perpetual existence commencing upon the filing of these articles.

**ARTICLE V:
REGISTERED AGENT AND INITIAL REGISTERED OFFICE**

ARTICLE VI: BOARD OF DIRECTORS

This Corporation shall have one director (s) initially. The number of directors may be increased or diminished from time to time by the Bylaws adopted by the stockholders, but shall never be less than one.

ARTICLE VII: INITIAL DIRECTOR

The Corporation shall indemnify any officer or director or any former officer or director, to the full extent of the law.
