**ARTICLES OF INCORPORATION  
OF

**Article One**

The name of this corporation is Creative Publishing Corporation, and the mailing address of the corporation shall be 2104 NE Van Loon Ter., Cape Coral, Fl 33909

**Article Two**

The date of the commencement of corporate existence of the corporation shall be the date these articles are executed, October 3<sup>rd</sup>, 2002

The duration of the corporation is perpetual.

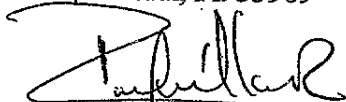

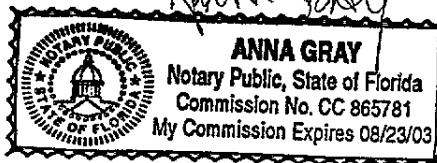
