

OF

ARTICLE I. NAME

The name of this corporation is

WELD-DONE, INC.

ARTICLE II. DURATION

This corporation shall have perpetual existence.

ARTICLE III. PURPOSE

This corporation is organized for the purpose of

ARTICLE IV. CAPITAL STOCK




