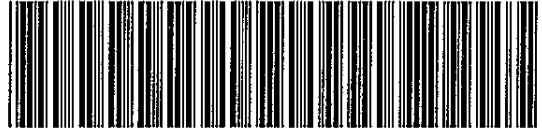

KNOW ALL MEN BY THESE PRESENTS: That pursuant to Section 607.187, Florida Statutes, the undersigned corporation hereby adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the corporation is GRETANJIM, INC.
2. The following Amendments are hereby made to the Articles of Incorporation of the corporation, due to errors made on the original Articles. The Amendments are made to Articles such that the Articles shall read, as Amended, as follows:

ARTICLE VI. REGISTERED OFFICE AND AGENT

The name of the initial Resident Agent is Greta Carter.

ARTICLE VIII. INITIAL DIRECTORS

The name of the initial Director is Greta Carter.

ARTICLE IX. SUBSCRIBERS

The name of the Subscriber to the Articles of Incorporation is Greta Carter.

All other provisions contained in the original Articles shall remain the same and these Articles of Amendment are solely to correct the name which was incorrectly provided due to a scrivener's error.
