ARTICLE I - NAME

The name of this Corporation shall be:
Marketing Consultants of Palm Harbor, Inc.

ARTICLE II - DURATION

This Corporation shall have perpetual existence commencing
on 10/09/02

ARTICLE III - PURPOSE


ARTICLE X - BY-LAWS
