
ARTICLE THIRTEEN



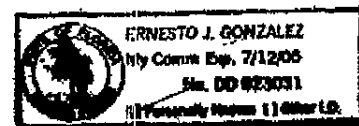
