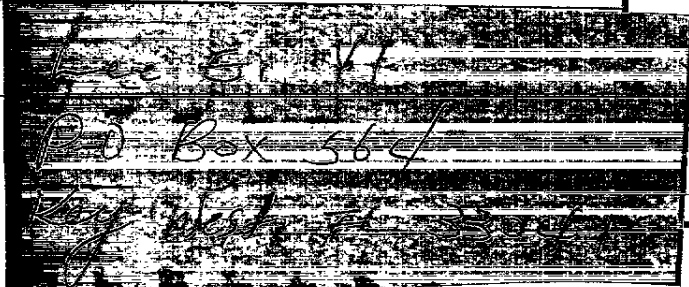

The undersigned, desiring to form a Corporation under the Laws of the State of Florida, hereby certifies as follows:

FIRST: The name of the Corporation shall be: **LEE IMPRESSIONS, INC.**

SECOND: The Corporation shall commence existence upon having its Articles of Incorporation filled by the State of Florida.

THIRD: The purpose for which this Corporation will be formed is as follows: to engage in and transact any or all lawful business for which a Corporation may be Incorporated under Chapter 607 of the Florida Statutes.

FOURTH: The aggregate number of shares which the Corporation shall have the authority to issue is Ten-Thousand (10,000) shares of Common Stock, each share having a par value of Ten Cents (\$0.10).

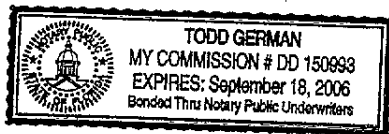
