**ARTICLES OF INCORPORATION
OF
PHYLLIS A. LAX, P.A.**

The undersigned subscriber to these Articles of Incorporation, currently licensed to practice law within the State of Florida and in her capacity as Incorporator of the captioned professional service corporation being formed under the Professional Service and Florida Business Corporation Acts, respectively Chapters 621 and 607, adopts the following Articles of Incorporation:

**ARTICLE I
Corporate Name and Principal Office**

The name of this corporation is PHYLLIS A. LAX, P.A., and its principal office and mailing address is 3904 Northampton Way, Tampa, Florida 33624.

**ARTICLE II
Commencement of Corporate Existence**

The corporation shall come into existence on October 10, 2002.

**ARTICLE III
General Nature of Business**

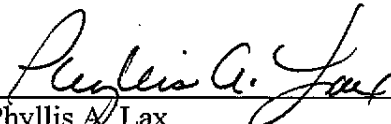

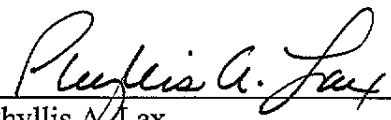
