ARTICLES OF INCORPORATION

CENTRAL FLORIDA TRUCK BODIES & REPAIR, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

Article 1. Name. The name of the corporation is: **Central Florida Truck Bodies & Repair, Inc.**

Article 2. Address. The address of the principal office of the corporation is 6550 Crestmont Glen Lane, Windermere, Florida 34786.

Article 3. Duration. The duration of the Corporation is perpetual.

Article 4. Purpose. The general purposes of which the corporation is organized are the following:

A. To engage in and transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in any way.

B. To do such other things as are incidental to the purposes of the corporation or necessary or desirable in order to accomplish them.

Article 5. Capital Stock. The aggregate number of shares which the Corporation is authorized to issue is one thousand shares of common stock. Such shares shall be of a single class and shall have a par value of one and no/100 dollars (\$1.00) per share.

Article 6. Initial Registered Office and Agent. The street address of the initial Registered Office of the corporation is 6550 Crestmont Glen Lane, Windermere, Florida 34786, and the name of the Registered Agent at that address is Jennifer Looney.

Article 7. Initial Board of Directors. The number of Directors constituting the initial Board of Directors is three (3). The number of Directors may be increased or decreased from time to time in accordance with the Bylaws but shall never be less than one. The name and address of the initial Director of the Corporation are as follows:

Article 8. Incorporator. The name and address of the Incorporator is as follows:

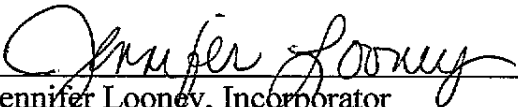

Article 10. Indemnification. The corporation shall indemnify each Officer and Director, including former offices and Directors, to the full extent permitted by law.

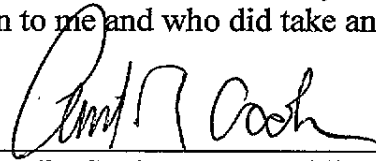

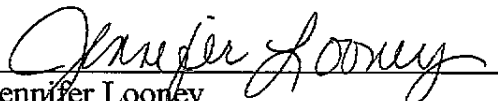
