Certificate of Incorporation
Of

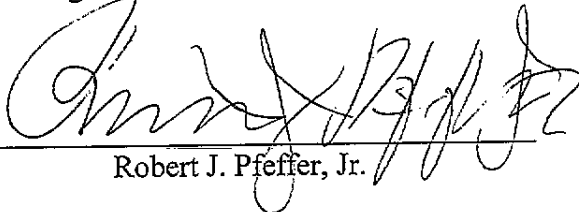

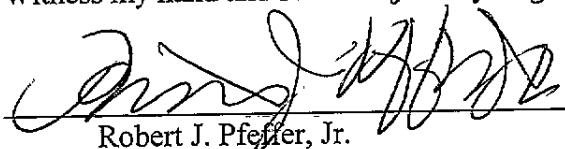

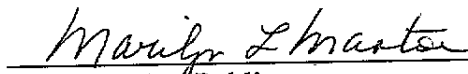
