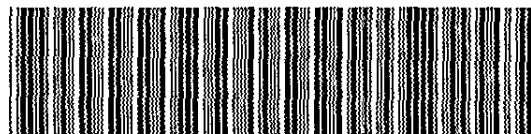




Article I of the Articles of Incorporation of BLACKWATER BUILDERS, INC.. is hereby amended to read:

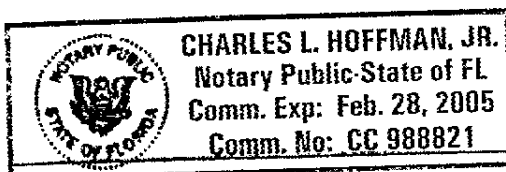
