**ARTICLES OF INCORPORATION
OF

The undersigned, acting as the incorporator of this corporation pursuant to Chapter 607 of the Florida Statutes, hereby forms a corporation for profit under the laws of the State of Florida and adopts the following Articles of Incorporation for such corporation:

ARTICLE I - NAME OF CORPORATION

The name of this corporation will be **Florida Wheelchair Ramps, Inc.**

ARTICLE II - TERM OF EXISTENCE

This corporation will commence its existence on October 10, 2002, and it will exist perpetually thereafter unless dissolved according to law.

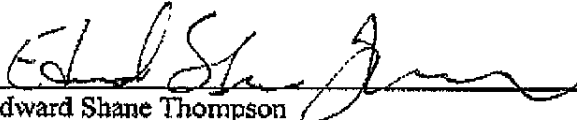
