Articles of Incorporation Of Acosta Produce Inc.

I, the undersigned, in order to form a corporation under pursuant to the provisions of the Laws of Florida for the purpose set forth below, hereby subscribe to these articles of incorporation.

I.

The name of the corporation shall be Acosta Produce Inc.

II.

The purpose and general nature of the business to be conducted and transacted by the corporation shall be as follows:

- A. To do and trasact any and all business as permitted under the laws of the State of Florida and the United States of America.
